LAW DEPARTMENT.

This Opinion appeared yesterday, without an opportunity for the writer to read a proof. It is printed to-day with his corrections and additions.]

No officer or department of the New York City Govern-ment, with the qualified exception of the Board of Health, can have or employ any attorney or counsel.

It is the duty of the Law Department to furnish to every department and officer such advice and legal assistance as counsel or attorney, in or out of court, as may be required by such officer or department, and he may assign an attorney to any department that he shall deem to

The law clothes the Counsel to the Corporation with a sound discretion as to whether a particular claim or de-fence insisted upon by any department or officer of the city government shall be carried to the courts for adju-

This discretion is not to be exercised capriciously, nor should the wishes of any officer or department be care-lessly or perversely disregarded.

A mere impression or even a conviction of the head of the Law Department that the judgment of another officer or department upon a question of law may be erroneous, is not of itself sufficient to justify a refusal to test such question in the courts.

But where the Counsel to the Corporation, after thorough examination and careful deliberation, determines that a litigation requested by another officer or department is utterly unjustifiable, and must prove unquestionably use-less, it is his duty to exercise the discretion imposed upon him by law, and decline to involve the city or its officers in the labor and expense of a contest in the

No department or officer is the client of the Counsel to the Corporation. His client is the city itself.

The claim against the City of New York for \$25,000, contracted by the Fire Department to be paid for a right to use what is known as the "Uda Fire Escape and Aerial Ladder," remitted to the Department of Finance for payment after suit commenced, upon the ground that it appears to the Counsel to the Corporation, after laborious examination and deliberation, that a defence would be unjust and fruitless of advantage to the city.

SIR-For a considerable period of time I have had before me, in various forms, for my official examination, a bill of Mary Bella Scott Uda, dated February 11, 1874, for \$25,000, which the Fire Department contracted to pay for a release and assignment of the right to manufacture and use for municipal purposes an improved fire escape and "aerial ladder." On the 28th of April last, as appears officially in the CITY RECORD (volume 2, No. 263, issued May 1, 1874), I sent you, in obedience to the proper requisition, an opinion to the effect: First. That the authority of the Fire Department to purchase implements convenient to the extinguishment of fire is amply secured by law, and extends to the purchase of rights secured tent laws of the U nited State That the provisions of the Charter requiring contracts for supplies to be awarded to the lowest bidder upon opportunity for competition do not apply to the acquirement of the right to manufacture an invention unique and distinctive in its character, covered by letters patent. Thirdly. That the 115th section of the Charter, providing that no patented article shall be advertised for, contracted for, or purchased, except upon competition, cannot be construed to deprive the Fire Department of the authority to purchase, without advertising for proposals, the right to use a patented and unique invention. And, Fourthly. That provisions of law, however useful, which relate to the mere mode of proceeding to reach an end must be regarded as sufficiently flexible to give way when a most important object is to be achieved, going to the very purpose of the maintenance of the municipal government. The

opinion covers all the points which, up to that the duty of the Law Department to furnish every period, had been raised in your office against the claim in question.

Months have elapsed. The claim has remained unpaid. A suit to recover the amount has been instituted against the city. Upon your official responsibility, as the head of the Department of Finance, you declare, that in your judgment payment should be withheld; and this being your conviction, no one has the right to question the exercise by you of the power to decline payment, leaving the claimant to resort to the courts. In the discharge of your duty, predicated upon the conviction which you avowed, you transmitted a summons and complaint to this office, and invoked the power of the Law Department to defend the city from this demand.

I have reconsidered the points of the opinion referred to. I have also given careful consideration to every suggestion which letters from me to your Department have been able to obtain as to the points of defense which in your judgment can be raised and maintained against the justice and legality of the claim.

My sober conviction is that, as a matter of law, the city cannot successfully resist the suit; and that, as a matter of justice and policy, the attempt ought not to be made.

The question then arises, whether, in spite of my convictions, I am bound by law or by a sense of official propriety to defend the case when in my own opinion the defence is both wrong and useless, certain to impose upon the city an expensive litigation, and place it before the courts and the country in an attitude utterly indefensible.

I have in numerous instances acted upon the supposition that the law imposes upon this Department a sound discretion as to whether or not the Corporation shall be involved in litigations. The subject, however, is of sufficient importance to receive a careful re-examination, and this I have

The City Charter, like all which have preceded it, divides the responsibilities of the municipal government among various departments, giving distinctive powers to each. It is made the duty of the Department of Finance to keep a debtor and creditor account with every person having dealings with the city, and it is given control of the fiscal concerns of the Corporation. To the Law Department it confides the charge and conduct of all the law business of the Corporation and its departments, and of all law business in which the City of New York shall be interested, with the limited exception of the operations of the Board of Health. When a matter is pending in the Department of Finance, the Department of Law is not given any jurisdiction over it, except to advise when the opinion of the Counsel to the Corporation may be asked. When a subject is remitted to the Department of Law, there is not a single sentence in the Charter from which an inference can be drawn that the Department of

Finance has any further control or power over it.

Before the passage of what is called the
Charter of 1873, the courts of judicature constantly presented the spectacle of legal contentions between different departments of the city government, each represented by counsel employed by itself. Large sums of money were constantly paid by different departments to enforce their respective views of public policy, and the common treasury was habitually drawn upon to pay counsel employed by one department, acting in one direction, and to pay counsel employed by another department, acting in another. From this state of things the public interests inevitably suffered. The tax-payers incurred enormous charges for litigations, not directed by a disinterested person, to the single advantage of the city, but controlled and urged by various departments ainst each other, with warmth engendered by contentions often of long standing.

To meet this manifest mischief, involving not only pecuniary loss, but public scandal, the Charter of 1873, among the wise provisions which atone for those not so wise, provided that no officer or department, except the Department of Health, should have or employ any attorney or counsel. Mark the words, "have or employ." Is the Counsel to the Corporation under the bid and direction of any other department? If this question must be answered in the affirmative, then the prohibition quoted amounts to this: that a department may have and employ the Counsel to the Corporation, though it may have or employ no other counsel. There is not, in the length of the Charter, a single sentence giving to any other department the power to control or direct the Department of Law.

But the Charter goes on to say that it shall be

department and officer such advice and legal assistance, as counsel or attorney, in or out of court, as may be required by such officer or department, and for that purpose he may assign an attorney to any department that he shall deem to need the same. It is hence the duty of the Counsel to the Corporation to furnish such advice and legal assistance, as counsel or attorney, in or out of court, as may be required by any other officer or department. If this language be construed to mean that any officer or department of the city may not only require the advice and legal assistance of the Counsel to the Corporation, but may also exercise over him unquestioned authority, then this officer is placed in the impossible position that the Department of Docks, for instance, may compel him to appear in court in a pending case upon the side which that department may happen to espouse, and at the same time the Department of Police, for instance, might require him to appear in court in the same case upon a precisely opposite side espoused by the department last mentioned. The mere statement of this inevitable result of the theory that the Counsel to the Corporation must be the mere instrument of any department that chooses to command him, is sufficient to refute it. No honorable member of the bar will permit any client to force him into the advocacy of a cause against his judgment and his conscience; and if the Charter requires this of the Counsel to the Corporation no upright lawyer would hold the position for an hour. He is undoubtedly to give his best advice, his best legal assistance, his best judgment, and his best services to every department or officer when required; but he would do neither of these things if he obeyed a behest contrary to his own opinion of law and his own sense of right.

No department or officer is the client of the Counsel to the Corporation, except in a representative capacity. His client is the city itself.

I cannot see what answer can be made to this view of the official responsibility of the head of the Law Department. Great responsibility is manifestly thrown upon him by the law; but his accountability is of equal magnitude. It would not do for him to decline to defend a case upon mere caprice, nor, in my judgment, would it be right for him to make such refusal merely because the inclination and impression of his own mind might be different from that of the head of another department, by whom he may be requested to defend a suit. Where, after the most careful examination and deliberation, he is satisfied beyond a doubt that a litigation will prove utterly useless, he should say so, and act accordingly. But where he can see that, notwithstanding his own convictions, there is room to suppose that an upright, able, and learned Court may differ from him, then he should not incur a responsibility to be more properly thrown upon the Judiciary.

These views have guided my official action from the first. The result of these principles of action has been that the Department of Law, under my control, has stood by the Department of Finance wherever the Counsel to the Corporation has believed that the Comptroller was or might be right, and has deliberately, carefully, and guardedly overruled him where the Counsel could not bring himself to believe that a litigation could by any possibility be right or useful. And in all cases he has conceded to the eminent head of the Finance Department the same integrity in judgment which he would claim for

The requirement of the Charter that all the transactions of the various departments shall be published in an official paper called the CITY RECORD, explains the publicity given to the instances of official action to which I have referred. It has been the fortune of the Department of Law to maintain relations of uninterrupted harmony with every department of the City Government, and especially with that with which it has naturally had most to do-the Department of

It has been the desire of the Counsel to the Corporation not to embarrass and obstruct, but to assist and advance, the interests of the city as represented in every one of the departments, and no complaint has reached him from any of them.

The points of defence of what is called the Uda claim, as they existed some months ago, were met in the opinion to which I have referred. The usefulness of the apparatus in question is nowhere denied. It was tested by the Fire Department of this city before they entered into this contract, and the test involved a large expense to the claimant. Numerous other cities of the United States bear

in their official records the strongest testimony. The highest officers of the navy of the United States in official reports add to the record. By means of it ladders can be projected and maintained in places utterly inaccessible without it. The documents of our own Fire Department show that at a comparatively recent fire in Centre street, New York, six lives which were sacrificed could have been saved by the use of it; and at other fires the ravages of the flames could have been stayed, and the rolls of death shortened, if the

city had possessed the invention.

In obedience to the justifiable and meritorious efforts of the Comptroller to defend the City Treasury from any hazard of depredation, I employed, long after my opinion in favor of the claim was rendered, an eminent lawyer to re-examine the patent and every pertinent matter relating to it in order to see whether the city was really gaining the right to use a useful apparatus, and whether there was any danger of a suit by other persons for an infraction of any similiar patents. The gentleman to whom I refer possessed intimate acquaintance with the officers of the Patent Office at Washington and with the bar of that city obtained during the exercise by him for eight years of the office of Solicitor of the Treasury, conferred upon him by President Lincoln at the recommendation of Secretary Chase. He made personal examinations of records and personal inquiries of patent lawyers both in Washington and this city. His written report, as I thought, left no doubt as to this claim. The claimant herself is a lady of the very highest character. Letters from the most eminent members of the judiciary at Washington and elsewhere, certify to her social standing and worth. There is no doubt that the purchase of these rights for the city by the Fire Department was effected at a most reasonable rate, with the distinct understanding that payment would be prompt, and that the adoption of the invention in New York would favorably affect negotiations in such other cities and places as had not already acquired the right.

Upon the Department of Finance, however, the responsibility of delayed payment ought not to be thrown in any spirit of censure, for there is no doubt that since my opinion was given, a gentleman of eminence in the law of patents, has expressed to certain officers in the Department doubts which justified further examination and deliberation. Under these circumstances, I felt it my duty, notwithstanding my own opinion, to so far defer to the judgment of the Comptroller and of the lawyer referred to, as to offer to retain the latter to test the matter before the courts. He has, however, recently declined the retainer, and written a letter which gives no encouragement, so far as his views are concerned, to the idea of a successful or just defence.

The claimant does not pretend to be the inventor of the apparatus. Indeed, the papers show that she is simply an assignee of the inventor's rights. She and her husband, in an instrument drawn in this office, released to the city the rights claimed by them. It has been suggested that the Corporation may hereafter be subjected to suit by other persons for an infringement, if they manufacture and use the instrument in question. No examination has revealed to me any sign of an adverse claim. It is perfectly

certain, however, that if the city should, as some have recommended, undertake to use the apparatus without the purchase of Mrs. Uda's rights, we should subject ourselves to a long and expensive litigation, if not to a short and disgraceful one. In good faith the Fire Department entered into

this contract with her, believing that she had rights which it was important to obtain, and so far as she is concerned to extinguish. They bargained with her to release her rights to the City, and she has done so. We have made the most thorough investigation, and find nothing to invalidate her claim to the ownership of the invention. Even assuming that there may be other and undiscovered claimants to these rights, I think it clear and certain, under all the circumstances, that in the suit which she has instituted, she is not only justly entitled to recover, but is perfectly certain of success.

It has been said that the patent claims perhaps too much, and is therefore invalidated as to what the patentee was really entitled to. Assuming that it does claim too much, still the patentee became entitled, under the letters, to the actual, meritorious, and useful invention claimed. This actual and useful invention is what the Fire Department, on behalf of the city, purchased, and what the claimant here, who is assignee of the patentee, purposes to release. By referring to the case of Hotchkiss v. Oliver (5 Denio, 314), it will be seen that the objection to the validity of the patent, founded upon the idea that it claimed more than what was actually invented by the patentee, could not be sustained.

The City of New York is constantly having many dealings, and cannot afford to act unjustly and unconscionably. Believing that the law imposes upon me a responsibility as to the proposed litigation, I cannot permit the city to go a single step in a suit which must result in a damaging exposure, and in an adverse and expensive verdict.

It would be pleasanter for me if no responsibility whatever attached to this office when a claim is sent here for litigation; but the law imposes a duty, and it must be met. The Comptroller is unquestionably right in transmitting the papers relating to a claim to this office, when he thinks it ought to be litigated, and the Counsel to the Corporation is equally right when he returns them, as I do here, with a most considerate and respectful report, that the claim cannot, in my judgment, be defended with the slightest hope of success, and must, therefore, be remitted to the Department of Finance for payment.

With regard to the propriety of such payment, several departments of the city, including your own, appear to have been long ago committed. A reference to the CITY RECORD, Vol. I., No. 127, issued November 19, 1873, will show the provisional estimate of the Board of Estimate and Apportionment for the year 1874. Under date of November 8, the Comptroller himself sent a letter to the Board of Aldermen, transmitting his annual "budget" for the year 1874, and accompanied it with the statement of the reasons for the allowance of the amounts therein specified. Under the head of the Fire Department appears the item, "For Improved Fire Escape and Life Saving Apparatus, \$25,000." The Comptroller adds that the aerial ladder is thought, by the Fire Department, to be a valuable addition to the apparatus for saving life and property. The Board of Estimate and Apportionment, composed of the Mayor, the Comptroller, the President of the Board of Aldermen, and the President of the Board of Taxes and Assessments, unanimously concurred in adopting the budget, including this item. The amount remains unexpended, and is directly applicable to the payment of Mrs. Uda's claim. This matter has been long before us, and I am aware of no considerations which have arisen, changing the matter as it stood at the date of my opinion of April 28, 1874.
