The Board of Health met this day.

### Orders.

### Resolutions.

Whereas, The district of the city, between Ninety-first and One Hundred and Ninth streets, Fifth avenue and the East river, is and has been for several years in a condition dangerous to life and detrimental to the public health, as appears from the records of this Department; and

Whereas, This condition is due to the fact that, in reclaiming the tidal land by filling, the surface has not been brought to a proper and uniform level, considerable areas have not been covered at all, and are consequently occupied by large pools of stagnant water, into one of which a sewer empties its contents, while other areas, often including many blocks, are so low as to be constantly saturated with water, and offensive; and

Whereas, No effective system of drainage has been adopted in this district, to take the place of the old water courses, which have been completely obstructed; and

Whereas, The only remedies which are available to correct the dangerous condition of this district are filling and draining; therefore

Resolved, That the Department of Public Works be and is hereby respectfully requested to complete, as speedily as possible, the extension of Lexington avenue, Madison avenue, First avenue, and the intersecting cross streets, to cause the stagnant pools to be filled, to put at least two feet of good earth upon the surface of the district between Ninety-third and One Hundred and Fourth streets, east of Third avenue, and to establish a comprehensive system of drainage, independent of and in addition to the sewers, all in accordance with the certificates requiring the drainage of such portion of the city, by and under the direction of said Department, heretofore made and forwarded in the year 1873, and again in May last by this Board, under and in pursuance of the provisions of chapter 566 of the Laws of 1871;

Resolved, That in the opinion of this Board there is no material save fresh earth better adapted for filling these sunken areas than clean coal ashes, and that the Board of Police be respectfully requested to collect these ashes free from garbage and street sweepings, and send the same to this district;

Resolved, That the Sanitary Superintendent be and is hereby directed to cause all the stagnant pools and sunken areas to be thoroughly disinfected, and to repeat such disinfection as often as may be necessary, and that he be also directed to inspect the privies of the houses on the east side of Third avenue, between One Hundred and Sixth and One Hundred and Eighth streets, cause them to be cleaned and disinfected, and, if necessary, to take the proper steps to cause said houses to be vacated, and that he be directed to place an Inspector in the district, with orders to prevent the dumping of any material save fresh earth and clean ashes;

Resolved, That the President and Chairman of the Sanitary Committee be requested to confer with the Mayor and the Commissioner of Public Works upon the importance of immediate action for the relief and improvement of this district.

That this Board respectfully acknowledges the receipt from the Board of Education of the following resolution:

"Resolved, That the Board of Health be respectfully solicited to co-operate with the School Trustees of the Twenty-second Ward, against the erection of an abattoir on the Hudson river, between Fifty-eighth and Fifty-ninth streets."

And respectfully states that this Board has no control over any building in course of erection at the foot of West Fifty-eighth and Fifty-ninth streets; and that, if any nuisance shall hereafter arise in that vicinity, this Board will be prompt to give it the necessary attention.

That the Sanitary Superintendent be directed to notify the President of the Board of Education, at least twice in each week, the names and places of residence of children sick of small-pox, pupils of the public schools.

That after July 31, 1875, no street cars will be permitted to be used in the streets of the city of New York in violation of section 164 of the Sanitary Code, which prohibits the use of cushions.

Whereas, In the opinion of this Board, night scavenging can and should be conducted in an entirely inoffensive and innoxious manner, and the process should be constantly subject to the severest scrutiny and inspection;

Whereas, The necessary supervision of the night scavengers, when working by night, has been found practically impossible, and reports are frequent of abuses in the work which cannot be followed by detection and punishment, because of the hour and the darkness when the work is performed; and

Whereas, The present manner of conducting this business without the use of improved, and the most efficient and perfect apparatus, successfully tried and adopted in other cities, creates a frequent nuisance, detrimental to health and dangerous to life; and

Whereas, By the performance of the work at night, houses are opened and dangers thereby arise, and foul air and gases are frequently disseminated through crowded buildings, at a time when the most who can receive injury are present therein, and also the noise of carts at night in the streets is injurious to invalids, and detrimental to health; and

Whereas, All these difficulties may be remedied by compelling the performance of the work of scavenging in daylight, and under inspection; therefore

Resolved, That the Sanitary Superintendent grant permits for scavenging during the hours between sunrise and sunset only, and that the work be not performed at any other time.

That on and after July 1, no blood or any offensive material shall be allowed to escape from any slaughter-house into or enter any sewer or stream of water, or be or remain in any place within the city limits where it may become a nuisance.

That on and after July 1st, no driving of beef cattle will be permitted between Fir st and Tenth avenues, in this city.

That the Department of Public Charities and Correction be respectfully requested to erect a small shed on the extremity of Small-pox Reception Hospital, inasmuch as said Department deem it "dangerous to the many visitors attending funerals, when compelled to assemble in a place where bodies are lying," and for the reason that this Board is not charged by law with the keeping or burial of bodies dead from small-pox.

### Sanitary Bureau.

The following is a record of the work performed by the Sanitary Bureau for the week ending June 5, 1875. The total number of inspections made by Inspectors was 2,132, as follows: 2 public buildings, 1,030 tenement houses, 159 private dwellings, 82 other dwellings, 13 manufactories and workshops, 9 stores and ware-houses, 67 stables, 3 ponds, 8 dumping grounds, 53 slaughter-houses, 4 fat-rendering, 2 manure dumps, 2 tripe boiling establishments, 8 public sewers and drains, 1 brewery, 1 roadway, 5 railroad cars, 62 sunken and vacant lots, 75 yards, courts, and areas, 121 cellars and basements, 100 waste-pipes and drains, 157 privies and water-closets, 20 street gutters and sidewalks, 10 dangerous stairways, 2 dangerous and smoky chimneys, 2 piggeries, 1 cistern and cesspool, 10 other nuisances, together with 83 visits of the Sanitary Inspectors to cases of contagious diseases.

The number of reports thereon received from the Inspectors was 865.

During the past week 81 complaints have been received from citizens, and referred to the Inspectors for investigation and report.

Permits have been granted to the consignees of 72 vessels to discharge cargoes, on vouchers from the Health Officer of this Port.

226 permits were granted to scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 126 premises where contagious diseases were found, and have disinfected and fumigated 113 houses, together with clothing, bedding, etc. They have also disinfected 3,347 privy-vaults, 41 cellars, 102 yards, and 148½ miles of street gutters.

87 cases of small-pox were removed to the hospital, and 2 dead bodies to the Morgue by the Ambulance Corps.

The following number of cases of contagious diseases were reported during the week ending June 5, 1875: Typhoid fever, 9; scarlet fever, 39; measles, 38; diphtheria, 97; small-pox, 126, and cerebro spinal meningitis, 4.

4,852 cans and 959 cans were removed by the night-scavengers from the privy-vaults of the city, during the week ending June 6, 1875.

During the week ending June 5, 1875, the following amount of meat and fish was condemned by the officers as being unfit for human food: cattle, 2 carcasses; calves, "bob," 1 carcass; calves, "case," 2 carcasses; beef, 130 pounds; poultry 147 pounds; and fish, 1,000 pounds.

### Bureau of Vital Statistics.

During the week ending June 5, 1875, there were issued from this Bureau 476 burial permits for city deaths, 27 for bodies *in transitu*, and 37 for the interment of still-born infants. There were recorded 476 deaths, 165 marriages, 413 births, 37 still-births, 27 applications for transit permits, and 63 returns from Coroners. There were 23 searches of the registers of births, marriages, and deaths, and 9 transcripts of birth-record, 2 of marriage, and 12 of death were issued from this Bureau. 3 cases of deaths were referred to Coroners.

On motion of Commissioner Voorhis, it was Resolved, That Rules 88 and 89 be and are hereby amended so as to read as follows:

Rule 88. The summer uniform shall consist of blue flannel sack coat, and blue flannel pantaloons. The coat of Patrolmen to be a single breasted sack, with short turn over collar, to button close up to the chin and to reach to a point four inches above the bend of the knee, with four buttons on the front; no pockets to show on the outside, and the pantaloons to be made same as winter pantaloons.

For Harbor Patrolmen—Flannel sack coat and flannel pantaloons, made like the above, and sennit hat.

Rule 89. Coats for captains to be double-breasted, to button close up to the chin, with short rolling collar, with two rows of buttons of five each on the front; the coat to reach to a point four inches above the bend of the knee; pantaloons to be without welt in the seams.

For sergeants same as captains, except that there shall be two rows of buttons of four each.

On motion of Commissioner Voorhis, it was Resolved, That the several pay-rolls of the Police Department and Street Cleaning Bureau shall be duly certified to by the several officers and clerks having charge and supervision of the services and time records of the persons mentioned on said roll, and shall, previous to payment being made thereon, be presented to and reported upon by the Finance Committee to the Board of Police, which shall, in its discretion, refer the said rolls, or any part thereof, to the Treasurer for payment—all voting aye.

On motion of Commissioner Smith, it was Resolved, That hereafter the meetings of the Committees of this Board shall be on regular days, and at regular hours, to be determined by the Board.

On motion of Commissioner Voorhis, it was Resolved, That the meetings of the Finance Committee be held on Tuesdays and Fridays at 10 A. M.

On motion of Commissioner Smith, it was Resolved, That the meetings of the Committee on Rules and Discipline be held on Mondays and Thursdays at 11 A. M.

On motion of Commissioner Disbecker, it was Resolved, That the meetings of the Committee on Street Cleaning be held on Mondays at 1 P. M., and Wednesdays at 11 A. M.

On motion of Commissioner Voorhis, it was Resolved, That the meetings of the Committee on Repairs and Supplies be held on Mondays at 3 P. M., and Fridays at 2 P. M.

I.—That we have completed our estimate and assessment in the above-entitled matter, and that all persons whose interests are affected thereby, and who may be opposed to the same, do present their objections in writing, duly verified, to the undersigned Commissioners, at our office, No. 57 Broadway (Room 24), in said City, on or before the 30th day of June, 1875, and that we, the said Commissioners, will hear parties so objecting, within the ten week-days next after the said 30th day of June, 1875, and for that purpose will be in attendance at our said office on each of said ten days, at 2 o'clock P. In the matter of the application of the Department of Public Parks and the Department of Public Works, for and in behalf of the Mayor, Aldermen, and Commonalty of the City of New York, relative to acquiring title to certain lands in the City of New York, for a public square or place, for a Parade Ground, and the streets and avenues bounding the said public square or place, as laid out by the officers composing the Board of the Department of Public Parks in the City of New York, and the Major-General Commanding the First Division of the National Guard of the State of New York.

PURSUANT TO THE PROVISIONS OF CHAPTER 290 and chapter 628 of the Laws of 1871, chapter 872 of the Laws of 1872, and chapter 335 of the Laws of 1873, and of all other statutes in such case made and provided, the Department of Public Parks and the Department of Public Works, for and in behalf of the Mayor, Aldermen, and Commonalty of the City of New York, hereby give notice that, in compliance with the act of the Legislature of the State of New York, entitled, "An act to alter the map or plan of the City of New York, and to authorize the taking of a public place for a parade ground, and to authorize the taking of the same," passed April 20, 1871, three-fifths being present, the Counsel to the Corporation of the City of New York will apply to the Supreme Court of the State of New York, at a Special Term of said Court, to be held at the Chambers thereof, in the County Court-house, in the City of New York, on Monday, the 28th day of June, 1875, at the opening of the Court on that day, or as soon thereafter as counsel can be heard thereon, for the appointment of Commissioners of Estimate and Assessment in the above-entitled matter.
