



BOARD OF ALDERMEN.

STATED SESSION.

TUESDAY, October 8, 1878, }

The minutes of the last meeting were read and approved.

MOTIONS AND RESOLUTIONS.

Alderman Slevin moved that when the Board adjourns it do adjourn to meet again on Monday next, the 14th inst., at 2 o'clock P. M.
The President put the question whether the Board would agree with said resolution.
Which was decided in the affirmative.

MESSAGES FROM HIS HONOR THE MAYOR.

The President laid before the Board the following message from his Honor the Mayor :

EXECUTIVE DEPARTMENT—CITY HALL, }
NEW YORK, October 8, 1878. }

To the Honorable the Common Council :

GENTLEMEN—I herewith return, without my approval, the resolution rescinding the resolution approved by the Mayor December 28, 1876, rescinding resolution approved March 15, 1870, authorizing the justices of the several police and civil courts to appoint janitors, and authorizing the justices of the police courts and the justices of the district civil courts to appoint janitors for each of said police and civil courts.

I am informed by the Counsel to the Corporation, in an opinion which is herewith transmitted, that it is not in the power of the Common Council to adopt this resolution, and I am therefore constrained to withhold my approval.

SMITH ELY, JR., Mayor.

Resolved, That the resolution approved by the Mayor December 28, 1876, rescinding resolution approved March 15, 1870, authorizing the justices of the several police and civil courts to appoint janitors, be and the same is hereby annulled, rescinded, and repealed, and that the justices assigned to each of the police courts of this city and the justices of the several district civil courts be and they are hereby authorized and empowered to appoint a janitor for each of said police and civil courts at an annual salary as now fixed by law.

Alderman Sauer moved that the opinion of the Counsel to the Corporation, accompanying the Mayor's message, be placed on file.

Alderman Morris, as an amendment, moved that the opinion be printed in the minutes in connection with the message from his Honor the Mayor.

The President put the question whether the Board would agree with said amendment.

Which was decided in the negative, on a division called by Alderman Morris, viz. :

Affirmative—Aldermen Biglin, Ehrhart, Jacobus, Kiernan, Morris, Perley, Phillips, and Pinckney—8.

Negative—The President, Aldermen Bennett, Carroll, Foster, Gedney, Guntzer, Hall, Lewis, Sauer, Sheils, and Slevin—11.

The President then put the question whether the Board would agree with the motion of Alderman Sauer.

Which was decided in the affirmative.

The message was then laid on the table, ordered to be printed in the minutes and published in full in the CITY RECORD.

The President laid before the Board the following message from his Honor the Mayor :

MAYOR'S OFFICE, }
NEW YORK, October 8, 1878. }

To the Honorable the Board of Aldermen :

GENTLEMEN—A committee of the New York Labor Union have presented to me the following communication :

At a meeting of the New York Labor Union, held on the first day of October, 1878, the following resolutions were unanimously adopted, and a committee appointed to present them to his Honor the Mayor :

Resolved, That we call upon the Mayor of the City of New York to recommend to the Board of Aldermen to adopt measures for the immediate prosecution of the following needful public improvements, in order to employ our people, beautify and render healthy our city, and restore our business and industrial prosperity :

First—The immediate repairing of our streets and repaving of streets where needed.

Second—The building and improvement of docks and piers.

Third—The building of a new aqueduct, with the basins, mains, etc., necessary to give us a proper water service.

Fourth—The filling in of Harlem flats, and other low, unhealthy, and marshy lands.

Fifth—The proper and efficient cleaning of our streets, and fumigating and deodorizing of yards, privies, and other seats of disease, so as to save our people from pestilence.

And we protest, as citizens, against the chartering of a monopoly to heat this city by the Holly or other system, and demand that in future all such works, needed by the public, be done by the city for the public good.

And we also protest against the dumping of our city's street sweepings in our harbor or river, and demand that it be utilized for the farmers of our vicinity to fertilize the barren soils of New Jersey, Westchester, and Long Island, as such a waste of the life-blood of our soil is both unwise and injurious to our people.

Hoping that the above petition will receive your attention and consideration, we will ever pray.

Pursuant to the request of the committee, I respectfully ask that the communication may receive your earnest attention, in view of the fact that in a few days you will be required to take action upon the estimates of expenditures for the coming year, and the amounts to be expended for the maintenance and improvement of the streets, docks, and public works of the city.

While I am in favor of the most rigid retrenchment in the expenses of the city government, I am of opinion that true economy and the best interests of the city will be promoted by undertaking at the present time all repairs and improvements which are now absolutely needed, or which will be required in the immediate future, while the city can have the benefit of abundant labor and low priced materials.

The broken and dilapidated condition of the pavements in many of our streets is a source of constant complaint, and the incapacity of the present aqueduct to supply the amount of water absolutely necessary for the wants of our citizens, which inadequacy will increase each year, makes it incumbent upon those who are intrusted with the control of the public affairs of this city to give the matter immediate attention.

Which was laid on the table, ordered to be printed in the minutes and published in full in the CITY RECORD, and, on motion of Alderman Slevin, the Clerk was instructed to acknowledge the receipt of the message, and to inform his Honor the Mayor that the Common Council would co-operate with him and the several departments of the city government, by every means in its power, in all measures tending to promote the objects sought to be obtained by the New York Labor Union.

Abstract of the Proceedings of the Department of Public Parks for the two weeks ending Saturday, September 28, 1878.

MEETING HELD SEPTEMBER 18, 1878.

Present—Commissioners Wenman (President), Wetmore, Conover, and Lane. Permission was given to Crook's Amateur Cornet Band to give an evening concert on the Mall, Central Park, on Friday, September 27, 1878.

The following preambles and resolution were adopted. Whereas, This Department, on the 20th day of February, 1875, made requisition on the Comptroller of the City of New York to issue bonds to the amount of one hundred thousand (\$100,000) dollars, in pursuance of the provisions of section 3, chapter 534, Laws of 1871, and section 16, chapter 329, Laws of 1874, for the construction of a bridge over Harlem river; and

Whereas, The Board of Estimate and Apportionment, on the 21st day of March, 1876, authorized the said Comptroller to issue said bonds to the amount of ten thousand (\$10,000) dollars; and

Whereas, No further action has been taken in the matter by the Board of Estimate and Apportionment, and the building of said bridge cannot be proceeded with until a sufficient amount of said bonds has been authorized to be issued by said Board of Estimate and Apportionment; therefore,

Resolved, That the Board of Estimate and Apportionment be and hereby is respectfully and urgently requested to authorize the Comptroller of said city to issue the residue of said bonds, namely bonds to the amount of ninety thousand (\$90,000) dollars, as mentioned in the aforesaid requisition of this Department of February 20, 1875.
