The time of payment of taxes for the years 1877, 1878, and 1879, with interest thereon at the rate of seven per cent, per annum, is extended to the first day of April, 1881 and if not paid before that date, interest will be payable at the rate of twelve per cent, per annum. COMPTROLLER'S OFFICE, JUNE 4, 1880. 1 CHAPTER 123. AN ACT in relation to arrears of taxes in the City of New York, and to provide for the reissuing of revenue bonds in anticipation of such taxes. Passed April 13, 1880; three-fifths being present. The People of the State of New York, represented in Senate and Assembly, do enact as follows: Section 1. At any time after the passage of this act, and before the first day of October, eighteen hundred and eighty, any person may pay to the Comptroller of the City of New York the amount of any tax upon real prop-erty belonging to such person, heretofore laid or imposed and now remaining unpaid, together with interest thereom at the rate of seven per centum per annum, to be calculated from the time that such tax was imposed to the time of such payment, provided, also, that the time when such payment may be made on the amount of any such tax laid or imposed in they ease eighteen hundred to the first day of April-eighteen hundred and eighty-one. The comptroller shall make and deliver to the person making any such payment; and upon such payment being made such tax shall cace to record of any such tax on the books of the finance department; and upon such payment being made such tax shall caces to be a lien upon the property and shall be deemed fully paid, satisfied and discharged, and there shall be no right to any further interest or penalty by reason of such tax not having been paid within the time heretofore required by law, or by reason of any statute passed requiring the payment heretofore of any penalty or interest over even per centum per annum upon any unpaid taxes are collect-ed, may be reissued by the comptroller of said city, in whole or in part, tor such period as he may determine, not exceeding one year.
