COMMISSIONERS OF THE SINKING FUND.

Abstract of the Proceedings of the Commissioners of the Sinking Fund, at the meeting held September 23, 1881:

Present—Hon. William R. Grace, Mayor (Chairman); Hon. Frederick Smyth, Recorder; Hon. Allan Campbell, Comptroller; J. Nelson Tappan, Esq., Chamberlain, and Joseph J. McAvoy, Esq., Chairman Finance Committee, Board of Aldermen.

The minutes of the last meeting were read and approved.

The Comptroller submitted the following reports, viz.:

I.

COMPTROLLER'S OFFICE, September 23, 1881.

To the Commissioners of the Sinking Fund:

GENTLEMEN—Herewith I present the application of Augustus Hoelzle, Captain Commanding Battery K., N. G. S. N. Y., for an armory and drill-room, duly certified by the Adjutant General of the State, as prescribed by the military code of the State of New York.

The lease of the premises formerly occupied by Battery K, on West Twenty-third street, expired on the 1st of May last and was not renewed, since which date it has had no quarters, and the cannon and accoutrements of the Battery have been stored at the State Arsenal on Seventh avenue.

The owner of the premises Nos. 334, 336, 338 and 340 West Forty-fourth street, has agreed to rent a portion required for the use of the Battery, for a term extending to May 1st, 1886, at an annual rent of \$2,750, and the present lessee has agreed to fit up and prepare the same for the accommodation of the Battery at his own cost and expense.

After due examination and inquiry, I am of the opinion the premises are adapted to the purpose and that the rent is fair and reasonable, and I recommend that authority be given to lease them, as provided by chapter 461 of the Laws of 1880.

Resolved, That the Counsel to the Corporation be requested to prepare a lease of a portion of the premises Nos. 334, 336, 338 and 340 West Forty-fourth street, as described and shown by an appraised valuation of the rental and diagram thereof, made for the Comptroller, for a term extending to the 1st day of May, 1886, at the rate of \$2,750 per annum, with the usual covenants and conditions, and such other conditions relating to taxes, repairs, Croton water rents, etc., as shall be approved by the Comptroller, who is hereby authorized to enter into and execute such lease when prepared and approved by the Counsel to the Corporation, as provided by chapter 461 of the Laws of 1880, and upon compliance with all the requirements of law applicable to the leasing of property for the use of the National Guard of the State of New York.

The report was accepted, and, on motion, the resolution was adopted.

II.

COMPTROLLER'S OFFICE, September 23, 1881.

To the Commissioners of the Sinking Fund:

GENTLEMEN—The Comptroller, to whom was referred the application of Jacob Vanderpoel for a quit claim deed of a certain lot of land, sold by the Corporation at public auction, May 21, 1866, designated as lot No. 3, of Plot L, on the map of said sale, respectfully

REPORTS:

It is alleged that the original deed of the land made by the Corporation to the purchaser, Joseph Kohner, deceased, has been lost or destroyed, as appears by an affidavit of F. W. Loew, the said deed not having been recorded in the Register's Office.

The said deed is duly recorded in the Comptroller's Office, and as is shown by the books of the Finance Department, a mortgage to the city on the property is still running for the sum of \$10,220, on which the interest has been duly paid up to June 15, 1881.

A resolution is submitted to authorize the Corporation Counsel to prepare a proper deed for execution by the Mayor and Clerk of the Common Council.

FINANCE DEPARTMENT—COMPTROLLER'S OFFICE,

To the Commissioners of the Sinking Fund:

GENTLEMEN—Herewith I present the petition of Michael McCarty, for a confirmatory deed of a lot of land, sold by the Corporation at a sale at public auction, held May 21, 1866, to Thomas Murphy, designated as Lot No. 48, of Plot "I" on the map of said sale.

The sale was regular and the terms complied with by the purchaser.

The amount of the purchase money has been paid in full into the City Treasury to the credit of the "Sinking Fund for the Redemption of the City Debt," as appears by the books of the Finance Department.

The reason assigned for asking for a confirmatory deed is, that the deed of the land sold by the Corporation was not signed by the then Mayor of the city.

The report was accepted, and, on motion, the resolution was adopted.

IV.

FINANCE DEPARTMENT—COMPTROLLER'S OFFICE,
September 23, 1881.

To the Commissioners of the Sinking Fund:

GENTLEMEN—By a resolution of the Common Council, approved by the Mayor August 4, 1881, a ferry was established "to run from a point at or near the foot of Twenty-third street, East river, in the City of New York, to and from a point at or near the foot of Quay street, in the City of Brooklyn, E. D."; and the Commissioners of the Sinking Fund were authorized and directed to sell at public auction, to the highest bidder or bidders, as provided by law, the right to operate the ferry so established, on such terms and conditions and subject to such restrictions and regulations as may be established by said Commissioners.

The ferry so established is necessary mainly for the transportation of passengers by railroad between the City of New York and the seashore at Coney Island, by the Manhattan Beach Railway Company.

The pier at the foot of Twenty-third street, East river, has been used by that company for the purpose of a ferry for several years past, under a lease from the Department of Docks which runs to May 1, 1882.

A proposition from that company is herewith presented offering to pay an upset price for the franchise to run said ferry, not exceeding five per centum upon the gross receipts for ferriage, on a lease for five years, from May 1, 1882, when the lease of the pier from the Dock Department will expire, including percentage dues at the same rate from May 1, 1881, to May 1, 1882; and also to pay the upset price for the rent of the said pier, as valued by the Department of Docks, not exceeding \$5,000 per annum, under a lease along with the franchise of the ferry for the same term to be sold at public auction.

I recommend therefore that authority shall be given for the sale at public auction of a lease of the said pier, along with the franchise of the ferry, from the foot of Twenty-third street to Brooklyn, pursuant to chapter 498, Laws of 1880, and submit a resolution for that purpose.

Resolved, That, pursuant to chapter 498, Laws 1880, the Commissioners of the Sinking Fund do hereby authorize the Comptroller to advertise and sell by public auction, to the highest bidder, a lease of the pier at the foot of Twenty-third street, East river, for the term of five years, from May 1, 1882, at an upset price of \$5,000 per annum, along with the franchise of the ferry to and from that point, established by a resolution of the Common Council, approved August 4, 1881, at the upset price of five per cent. upon the gross receipts for ferriage, on the terms and conditions of sale prescribed by a resolution, adopted by this Board March 17, 1881, in relation to the sale of certain ferry leases and according to the requirements of the law and the ordinances of the Common Council.

The report was accepted, and, on motion, the resolution was adopted.

The Comptroller submitted the following resolution which, on motion, was adopted, viz.:

Resolved, That the Counsel to the Corporation be requested to prepare a lease of the premises of the second story of the building bounded by Broadway, Sixth avenue, Thirty-fifth and Thirty-sixth streets, to be occupied as an armory and drill-room by the Seventy-first Regiment, N. G. S. N. Y., for the term of one year from May 1, 1881, at the yearly rent of \$11,000, with the usual covenants and conditions, and such other covenants relating to taxes, repairs, and Croton water rents as are contained in the previous lease, and as may be approved by the Comptroller, who is hereby authorized to enter into and execute such lease when so prepared and approved by the Counsel to the Corporation, as provided by chapter 461, Laws of 1880, and upon compliance with all the requirements of law applicable to the leasing of property for the use of the National Guard State of New York; and the resolution adopted April 27, 1881, authorizing a lease of the same premises is hereby rescinded.

The petition of Albert Crane, Benjamin F. Crane, and Clarissa L. Crane for release of the right, title, and interests of the city in certain lands on the East river, between Ninety-fourth and Ninety-fifth, and Ninety-ninth and One Hundredth streets, was received, and, on motion, referred to the Comptroller.

The Comptroller submitted the opinion of the Counsel to the Corporation in relation to the powers of the Commissioners of the Sinking Fund in the matter of an extension of the lease of the lands now occupied by the German Hospital and Dispensary of the City of New York, as empowered by act, chapter 272, of the Legislature of the State of New York, passed May 13, 1881; which, on motion of the Recorder, was laid over.

APPROVED PAPERS.

Whereas, His Honor the Mayor has officially communicated to this Common Council the sad intelligence of the death of James A. Garfield, President of the United States, and has recommended that appropriate action be taken by the municipal authorities, to give expression to the profound grief of the people of this city, in view of this great national calamity; and

Whereas, In bowing in submission to the will of Divine Providence, and in acknowledging the inscrutable ways of Him who rules the destiny of men and nations, in thus afflicting us, by taking to Himself the chosen administrator of the government of this great republic, it is eminently proper that we should meekly and submissively accept from His chastening hand this dread evidence of His power; that we should deplore the sad event; that we should sympathize with those who are more directly afflicted by the President's death—his bereaved wife, and his fatherless children—and that we should fervently supplicate our Heavenly Father, of his mercy to accept the death of President Garfield as a propitiatory sacrifice, which will secure for us the divine favor, and bring the people of this country to a realizing sense of their total dependence upon the goodness of God; be it therefore

Resolved, That, in the universal sorrow for the death of President Garfield, it is the sad duty of the people of this city to participate, and as their representatives in this Common Council, it is incumbent upon us to take such measures as will tend to give public expression to their profound grief; to deprecate the abominable crime that led to the death of our beloved Chief Magistrate, and to sympathize and condole with his afflicted relations, his stricken wife and bereaved family;

Resolved, That it is hereby recommended to our citizens to close their respective places of business and refrain from any secular employment on the day set apart for solemnizing the funeral rites and ceremonies; that the members of the Common Council will attend his funeral in a body, should his remains be brought to this city, with their staves of office draped in mourning, and will wear a badge of mourning for a period of thirty days; that the flags on the City Hall, and the other public buildings, be displayed at half-mast from sunrise until sunset each day, until and including the day of the funeral, and the owners or occupants of private buildings in this city, and the owners or masters of vessels in our harbor, be requested to display their flags in like manner, for the same period, and that a special committee of nine members of this Common Council be appointed to perfect the above, and, after consultation with his Honor the Mayor, and the heads of the departments of the municipal government, and in concert with them, make such other and further arrangements as to them may appear better calculated more clearly and impressively to manifest sorrow for the death or reverence for the memory of the deceased; and be it further

Resolved, That, as an additional evidence of respect for the memory of the deceased President, the Board do now adjourn.

If exempt, the party must bring proof of exemption; if liable, he must also answer in person, giving full and correct name, residence, etc., etc. No attention paid to letters.

Persons "enrolled" as liable must serve when called or pay their fines. No mere excuse will be allowed or interference permitted. The fines if unpaid will be entered as judgments upon the property of the delinquents.

All good citizens will aid the course of justice, and secure reliable and respectable juries, and equalize their duty by serving promptly when summoned, allowing their clerks or subordinates to serve, reporting to me any attempt at bribery or evasion, and suggesting names for enrollment. Persons between sixty and seventy years of age, summer absentees, persons temporarily ill, and United States and District Court jurors are not exempt.

Every man must attend to his own notice. It is a misdemeanor to give any jury paper to another to answer. It is also punishable by fine or imprisonment to give or receive any present or bribe, directly or indirectly, in relation to a jury service, or to withhold any paper or make any false statement, and every case will be fully prosecuted.

NOTICE TO TAXPAYERS.

RELATING TO THE PAYMENT OF UNPAID TAXES, ASSESSMENTS, AND CROTON WATER RENTS.

THE COMPTROLLER OF THE CITY OF NEW York hereby gives notice to owners of real and personal estate in this city, that all unpaid taxes, assessments, and Croton water rents may now be paid with interest thereon at the rate of seven per cent. per annum, as provided by chapter 33 of the Laws of 1881, which is as follows:

CHAPTER 33.

AN ACT relative to the collection of taxes and assessments, and of arrears of taxes and assessments, and Croton water rents, in the City of New York. (Passed March 16, 1881; three-fifths being present.)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. If any taxes of any year shall remain unpaid on the first day of November, after the assessment-rolls and the warrants to collect such taxes have been delivered to the Receiver of Taxes in the City of New York, it shall be the duty of said Receiver to give public notice, by advertisement for at least ten days in two of the daily newspapers, and in the CITY RECORD, printed and published in said city, respectively, that unless the same shall be paid to him at his office on or before the first day of December, in any such year, he will immediately thereafter proceed to collect such unpaid taxes, as provided in the following section of this act:

Section 2. If any such tax shall remain unpaid on the said first day of December, it shall be the duty of the said Receiver of Taxes in said city to charge, receive, and collect upon such tax so remaining unpaid on that day, in addition to the amount of such tax, one per centum on the amount thereof; and to charge, receive, and collect upon such tax so remaining unpaid on the first day of January thereafter, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated from the day on which said assessment-rolls and warrants shall have been delivered to the said Receiver of Taxes to the date of payment.

The same rate of interest shall be so charged and collected upon any tax levied in the year eighteen hundred and eighty, remaining unpaid at the date of the passage of this act.

Section 3. All existing provisions of law which impose a charge and require the collection of interest at the rate of twelve per centum per annum upon arrears of taxes on real and personal estate within the City of New York, upon arrears of assessments for local improvements and street openings in said city, and upon arrears of Croton water rents in said city, are hereby repealed; and in lieu of such charge of interest at the rate of twelve per centum per annum, there shall be charged and collected by the officer authorized to collect and receive any such arrears of taxes and assessments and Croton water rents, interest upon the amount thereof at the rate of seven per centum per annum, to be calculated for the same period as interest at the rate of twelve per centum per annum is now required by law to be calculated thereon. This provision shall apply to taxes, assessments, or Croton water rents remaining unpaid and due, for the non-payment of which the lands and tenements liable therefor shall be hereafter sold at public auction as now provided by law; provided, however, that nothing in this act shall be construed to affect the rights of purchasers at sales for taxes, assessments, or Croton water rents, heretofore made, or to authorize the redemption of lands and tenements from sales heretofore made for any lesser sums than the sums collectible for such redemption upon the provisions of existing laws.

Section 4. It shall be the duty of the Comptroller of the City of New York to give public notice, by advertisement, for at least ten days, in the CITY RECORD, printed and published in said city, immediately after the confirmation

of any assessment for a local improvement or street opening in said city, that the same has been confirmed specifying the title of such assessment and the date of its confirmation by the Board of Revision and Correction of Assessments in proceedings for local improvements, and by the Supreme Court in proceedings for street openings, and also the date of entry in the record of titles of assessments kept in the Bureau for the Collection of Assessments, and of Arrears of Taxes and Assessments, and of Croton water rents, notifying all persons, owners of property affected by any such assessment, that, unless the amount assessed for benefit on any person or property shall be paid within sixty days after the date of said entry of any such assessment, interest shall thereafter be collected thereon as provided in the following section of this act, and all provisions of law or ordinance requiring any other or different notice of assessments and interest thereon are hereby repealed.

Section 5. If any such assessment shall remain unpaid for the period of sixty days after the date of entry thereof in the said record of titles of assessments, it shall be the duty of the officer authorized to collect and receive the amount of such assessment, to charge, collect, and receive legal interest thereon, at the rate of seven per centum per annum, to be calculated from the date of such entry to the date of payment.

Section 6. This act shall take effect immediately.

ORDER OF THE COMPTROLLER OF THE CITY OF NEW YORK, CONSOLIDATING CERTAIN BUREAUX IN THE FINANCE DEPARTMENT.

SECTION 3 OF CHAPTER 527 OF THE LAWS OF 1880, requires that heads of departments shall reduce the aggregate expenses of their respective departments by a reduction of salaries, and confers upon them authority to consolidate bureaux and offices for that purpose, as follows, to wit:

"In making the reduction herein required, every head of department may abolish and consolidate offices and bureaux, and discharge subordinates in the same department."

The Comptroller of the City of New York, in pursuance of the duty imposed and the authority thus conferred upon him, hereby orders and directs that the following Bureaux in the Finance Department shall be consolidated, the consolidation thereof to take effect on the first day of January, 1881, viz.:

First—"The Bureau or the Collection of Assessments, and "The Bureau for the Collection of Arrears of Taxes and Assessments and of Water Rents," shall be consolidated as one bureau, and on and after January 1, 1881, shall be known as "The Bureau for the Collection of Assessments and of Arrears of Taxes and Assessments and of Water Rents," and possess all the power conferred and perform all the duties imposed by law and ordinance upon both said bureaux, and the officers thereof, the chief officer of which consolidated bureau shall be called "Collector of Assessments and Clerk of Arrears."

Second—"The Bureau for the Collection of the Revenue accruing from rents, and interest on bonds and mortgages, revenue arising from the use or sale of property belonging to or owned by the city," and "The Bureau of Markets," shall be consolidated as one Bureau, and on and after January 1, 1881, shall be known as "The Bureau for the Collection of City Revenue and of Markets," and possess all the powers conferred and perform all the duties imposed by law and ordinance upon both said Bureaux, and the officers thereof; the chief officer of which said consolidated Bureau shall be called "Collector of City Revenue and Superintendent of Markets."
