



LEGISLATIVE DEPARTMENT.

BOARD OF ALDERMEN—FEBRUARY 13, 1883.

At a meeting of the Board of Aldermen, held in the chamber of the Board, in the City Hall, on Tuesday, February 13, 1883, on motion of Alderman McLoughlin, the Committee on Ferries and Franchises was discharged from the further consideration of the following petition. It was then ordered to be printed in full in the CITY RECORD, and then recommitted to the Committee.

A PETITION.

To the Honorable Board of Aldermen of New York City, from the German-American Citizens' Association of Long Island City:

We respectfully state that the East River Ferry Company, incorporated May 3, 1860, their capital stock was \$180,000, and limited to one million dollars; certificate of determination to incorporate \$150,000, and filed November 10, 1868; they organized under the law by act, chapter No. 135, passed April 9, 1853; the law under which they organized required first to pay half capital in one year and the balance in two years, from incorporation certificate of such payment, to be filed with the Secretary of States, or the Corporation to be dissolved, half capital stock must be paid in before commencing business, and an annual report to be made to stockholders and filed in the Secretary of State's office at Albany, and in the County Clerk's office of New York; if reports thus made are false, all directors parties thereto are personally liable, see chapter 135, Laws of 1853, under which the above company organized, see Statute at Large of New York, Edmunds' edition, Vol. 3, Page 812. The only report made by this company since the date of its incorporation was made November 10, 1868, and is as follows:

The East River Ferry Company statement filed in Secretary of State's office in Albany, we, the undersigned, a majority of the directors of the East River Ferry Company, do testify that an increase of the capital stock of said company in the sum of \$150,000 has been determined upon at a special meeting of the stockholders of said company, called for that purpose on the 10th day of November, A. D. 1868, dated November 10, 1868.

So you can see this company has defied the law for twenty-two (22) years, and only complied with the commands but once since it was organized.

We would respectfully state that upon several occasions the people of Long Island and the people of New York petitioned their representatives in the Senate and the Assembly of this State to introduce and pass a bill for the reduction of ferriage for foot passengers from four (4) to two (2) cents, and passed the Assembly on many occasions, and on as many occasions was beaten in the Senate, and we believe, through the corrupt means resorted to by this law-defying community and political demoralizing corporation; the people failing to get their wrongs redressed.

We petitioned the Honorable Board of Aldermen of New York City, of 1882, for a reduction of ferriage for foot passengers from four to two cents on East Thirty-fourth street ferry; that petition was referred to the Committee on Ferries and Franchises, who reported as follows to the Board of Aldermen on the 26th day of September, 1882, see CITY RECORD, September 27, 1882, in which you will find the following report:

That your Committee having investigated the subject so referred, are convinced that the sum named in the resolution is ample to remunerate the company for the service rendered.

The subject has been agitated for some time, but as the company operated the ferry under a lease it was not in the power of the city to interpose in favor of the people who patronized this ferry until the expiration of the lease which will occur November 1, 1882.

When a new lease is made it should contain a stipulation that the rate of ferriage shall not exceed two cents each for adult foot passengers. The time has now arrived when action looking to this end should be taken by the Common Council.

The following resolution is therefore offered for your adoption:

Resolved, That in disposing of the lease of the ferry from the foot of East Thirty-fourth street, after the expiration of the present lease, November 1, 1882, the Commissioners of the Sinking Fund be and they are hereby instructed to include a stipulation in the new lease that the ferriage for each adult person crossing upon the boats of said ferry each way shall not exceed two cents, and that the same Commissioners give notice, before the sale of said ferry franchise, that the stipulation above named will be one of the conditions of the new lease.

Alderman Waite moved that the report be laid over.

The President put the question whether the Board would agree with said motion.

Which was decided in the negative, by the following vote, on a division called by Alderman

Levy:

Affirmative, 9; negative, 11.

The President then put the question whether the Board would agree to accept the report and adopt the resolution.

Which was decided in the affirmative by the following vote, viz.:

Affirmative, 14; negative, 6.

This resolution was vetoed on the 10th day of October, 1882, by the Hon. W. R. Grace, at that time Mayor of your city, and it was again passed over the Mayor's veto by a unanimous vote on the 24th day of October, 1882, which we submit as printed in the CITY RECORD of October 25, 1882:

The President, by unanimous consent, called up veto message of his Honor the Mayor of resolution, as follows:

Resolved, That in disposing of the lease of the ferry from the foot of East Thirty-fourth street, after the expiration of the present lease, November 1, 1882, the Commissioners of the Sinking Fund be and they are hereby instructed to include a stipulation in the new lease that the ferriage for each adult person crossing upon the boats of said ferry, each way, shall not exceed two cents, and that the said Commissioners give notice before the sale of said ferry franchise, that the stipulation above named will be one of the conditions of the new lease.

The Board then, as provided in section 13 of chapter 335, Laws of 1873, proceeded to reconsider the same, and, upon a vote being taken thereon, was adopted, notwithstanding the objections of his Honor the Mayor, as follows:

Affirmative—Unanimous—20 votes.

Your Honorable Body will see by the resolution adopted by the Honorable Board of Aldermen on the 26th day of September, 1882, that the lease to that franchise expired on November 1st last, 1882, and yet the Sinking Fund Commissioners of your city took no action on the matter, until a few days before the first day of January, 1883, when two of the Sinking Fund Commissioners, Alderman McClave and Mayor Grace, were retiring through their term of office expiring, when they ordered the following franchise "For Sale," which we took from the CITY RECORD of January 19, 1883:

SALE OF FERRY.

The franchise of the ferry between Thirty-fourth street, East river, and Long Island City, along with the wharf property used for ferry purposes, belonging to the Corporation of the City of New York, will be sold at public auction to the highest bidder, at the Comptroller's office, at 12 o'clock, noon, on Friday, January 19, 1883, by order of the Commissioners of the Sinking Fund, under a resolution adopted December 27, 1882.

TERMS AND CONDITIONS.

The franchise of the ferry and the wharf property, foot of Thirty-fourth street, East river, will be offered for sale at the time and place mentioned above, on a lease for a term of five years, from the first day of February, 1883, at a minimum yearly rental of \$2,000 for the wharf property used and required for ferry purposes, payable quarterly in advance, and a minimum rental of the franchise or right to operate said ferry, of five per cent. of the gross receipts of ferriage from foot passengers and vehicles, payable within ten days after the expiration of each quarter; and it is provided that the ferriage for foot passengers, from 5 to 7 A. M., and from 6 to 7 P. M., shall be two cents each, and at all other hours shall not exceed three cents for crossing said ferry, and that the rates of ferriage now charged for carriages, trucks, carts, and other vehicles shall not be exceeded during the term of the lease. The usual covenants and conditions prescribed by law, and the ordinances of the Common Council will be contained in the lease, a form of which, prepared by the Counsel to the Corporation, is on file in the Comptroller's Office for examination.

The highest bidder will be required to pay the auctioneer's fees, and deposit with the Comptroller, at the time of sale, the sum of \$500 on the purchase of the franchise of the ferry, which sums shall apply to the rent thereof first falling due if the lease is executed, and shall be forfeited to the city if the purchaser shall fail or refuse to execute the lease when notified and required by the Comptroller; provided also, that satisfactory security shall be furnished for the faithful performance of the covenants thereof.

The right to reject any bid is reserved if deemed for the interest of the city.

Your Honorable Body will see that this order of the Sinking Fund Commissioners, adopted December 27, 1882, is in direct conflict with the resolution adopted by the Board of Aldermen of New York City, on the 26th day of September, 1882, and which will make the sale of said franchise null and void, as it was ordered for sale in defiance of the instruction received from the Honorable Board of Aldermen of New York; the Legislative Body of and for the people of New York; you will see that capitalists did not bid for a franchise, the sale of which might be set aside by the courts of law.

We would respectfully call your attention to a meeting of the Dock Commissioners of New York, held on the 17th day of January, 1883, of which the New York World, of the 18th day of January, 1883, makes the following report, which we respectfully submit to your Honorable Body:

The Dock Commissioners and the Comptroller—At a meeting of the Dock Commissioners, yesterday, Mr. McDaniels, a law clerk in the Comptroller's Office, said that proposed sale of the franchise and the lease of the water-front, occupied by the Thirty-fourth Street Ferry Company, had been advertised to take place at the County Court-house, on Friday, and that the upset price had been set down at \$2,000 a year. Mr. Laimbeer and the other Commissioners expressed the opinion that the Comptroller had neglected the usual custom of requesting the Dock Commissioners to report on the upset price of the annual lease of the water-front, and had himself fixed it at \$2,000 dollars; the Erie Railroad paid \$12,500 a year for their ferry-house at the foot of West Twenty-third street, and charged only three cents ferriage, while the Thirty-fourth Street Ferry, which did twice as much business, and charged four cents, was going to have its lease for only two thousand (\$2,000). Mr. Laimbeer also said that he could, any day, find sixty persons who would be willing to pay \$6,000 for the lease. He emphatically protested against the action of the Comptroller.

We would further state, that Hon. J. J. Cullen passed this two-cent reduction bill through the Assembly of 1882, with only two votes against it in that body; when it was referred to the Senate Committee of Commerce and Navigation, Ex-Mayor Grace and Comptroller Campbell sent a protest against its passage, in which they claimed that the New York Board of Aldermen and the Sinking Fund Commissioners had that power vested in them jointly and together; but you will see that the Sinking Fund Commissioners of 1882 have ignored the Board of Aldermen and defied their resolutions as adopted by them.

We would respectfully invite your attention to a petition of the German American Citizens' Association, presented to the Board of Aldermen, on the 17th day of October, 1882, which was printed in the CITY RECORD on the 18th day of October, 1882. In that petition we have shown how this ferry company have run the politics of this county by contaminating and demoralizing political conventions, and beating, with their ill-gotten money, the Hon. John Keegan, our Assemblyman of 1878, who at our request and the request of the Board of Aldermen of Long Island city, and the Board of Supervisors of Queens County, he passed the bill at our joint request in opposition to attempted bribery, but since that time has been punished severely and almost hounded to death by this company. We will submit an extract from the "Long Island Beobachter," the German official paper of this city, which was translated for and republished in the "Long Island Courier," another official paper in this city.

We cannot forbear to gratefully remember a man who sacrificed his position and business in the campaign that finally determined in the victory of the people over the monopoly.

We mean Hon. John Keegan. Again and again he began the struggle against the ferry company, again and again he urged the people to continue the fight. All measures of his opponents were not sufficient to discourage him. They tried to bribe him, they tried to politically kill him, they drove him out of his position—a position which he held for thirty years—for the purpose of humbling him by distress, but only with renewed and increased vigor he endeavored to give the people their rights.

In the German Citizens' Association of Long Island City Mr. Keegan found strong assistance. Promptly they stood by his side; by delegating committees and sending petitions to the proper authorities, they succeeded in convincing them that a reduction of ferriage on the Thirty-fourth Street Ferry was a necessity, and they finally accomplished their purpose.

We should advise the Citizens' Association to arrange an ovation for the celebration of this triumph, and to tender Mr. Keegan an invitation as a proof of the gratefulness of the citizens for the great services rendered by him.

This is the way in which that illegal company punish public men in this place, and the consequence is that public men here are generally afraid to give any sincere opposition to them, as the company control conventions and run the politics of this place, as one of the engineers employed by the company is a Street Commissioner, a Water Commissioner, and also Chief Engineer of the Water Department of Long Island city; you can see by this truthful statement that the ferry company's influence is very strong in this place, but when aided as it is by the Brooklyn Ferry Company, who last winter through some of its officers attempted to bribe one of the New York assemblymen, who to his honor and credit be it said, refused the tempting offer and ignored their influence and passed the bill; that ferry company that can afford to loose \$200,000 in a few years, as they charge in a court of law, through their officers, as you will see by reading the following extract taken from the "New York Daily News," of January 18, 1883, which we respectfully submit to your Honorable Body:

"A 'News' reporter who made some inquiries to-day in connection with Moore's arrest found the ferry company's officers reticent, except as to the fact that they acknowledged that they believed Moore was guilty of embezzling the money, and that he had purchased his houses with it. The reporter, however, ascertained that it has been discovered that there have been constant and systematic peculations by some one or more of their employees since George Law's death, amounting in all, it is estimated, to \$200,000. A remarkable fact about the matter is that it is claimed by Moore's friends that the money he turned into the company as his receipts was more than that returned by any other ferry-master. Moore denies positively that he ever took a cent belonging to the company; but does not explain how he acquired his wealth. When the 'News' reporter questioned Colonel Spencer, Moore's counsel, on this point, the lawyer, with an admixture of seriousness and jest, replied:

"Young man; that is none of your business. A man may acquire money in various ways; by speculation, for instance, in Wall street."

"Did Mr. Moore, Colonel, speculate in Wall street?"

"I don't know; I did not ask him that question, because I think it is impertinent. He told me that he never took a cent except his salary from the company, and that is enough for me."

The other ways in which Colonel Spencer hinted a man might honestly make money he did not enumerate, and the reporter sought to help him out by suggesting lottery and other legitimate schemes; but the Colonel had inquired to this extent from his client, and he could not answer. Moore is a relative by marriage to a patrolman on the police force of this city who is reported to be worth \$60,000.

A friend of the accused ferry-master told the reporter that Moore was of a very saving disposition, and "did not spend five dollars upon himself for pleasure in a year." When Moore was

rearranged to-day in the Essex Market Police Court, J. J. O'Donohue, president of the New York and Brooklyn Ferry Company, was present. Colonel Spencer asked for his discharge, stating that he defied the company to prove that his client stole one dollar. They talked, he said, about \$40,000, but they would have to prove that Moore appropriated that sum dollar by dollar. Moore was held in bail. It is said that the ferry company will seek to attach Moore's personal and real property, and bring a civil suit against him. Before Moore was brought to court, this afternoon, his counsel informed the reporter that the company had made overtures of a compromise, but that the defendant had indignantly spurned them, asserting his innocence.

We beg of your Honorable Body to protect us, as you are our sole reliance, as we have applied to the Long Island City Board of Aldermen for assistance, but whose president declares there is no money in the treasury for such a purpose, and the Board of Supervisors of this county have taken no action upon a resolution submitted to them asking for a counsel fee to bring the matter into Court.

We beg of your Honorable Body to maintain your own rights as Legislatures for the people of New York, and be charitable enough to do us that justice that we failed to receive from the Ferry Company or the officials of this Long Island.

SALE OF FERRY FRANCHISES.

The Thirty-fourth Street Ferry.

A lease of the franchise of the ferry between Thirty-fourth street, East river, and Long Island City, along with the wharf property used for ferry purposes, belonging to the Corporation of the City of New York, at the foot of said street, will be sold at public auction, to the highest bidder, at the Comptroller's office, at 12 o'clock, noon, on Tuesday, February 13, 1883, by order of the Commissioners of the Sinking Fund, under a resolution adopted January 24, 1883, as provided by chapter 498, Laws of 1880.

TERMS AND CONDITIONS.

The lease of the franchise or right to operate said ferry, along with the said wharf property will be offered for sale at the time and place above mentioned, or a lease for the term of five years from the first day of March, 1883, at a minimum yearly rental or upset price of five per cent. of the gross receipts from all ferriages at said ferry for the franchise thereof, along with the said wharf property, at an additional yearly rental of \$2,000, payable quarterly, the said to contain all such covenants and conditions as are required by law and ordinances of the Common Council and are prescribed by resolutions of the Sinking Fund relative to the leasing of ferries and wharf property, upon a form of lease prepared by the Counsel to the Corporation, and filed in the Comptroller's office; provided, also, that the ferriage of foot passengers over said ferry shall not exceed three cents each, and that the rates of ferriage for trucks, carriages, and vehicles of all kinds, and for horses, cattle, and other animals, shall not exceed, during the term of said lease, those heretofore are now charged at said ferry; and that sworn returns of the gross receipts from all ferriages shall be made by the lessee, quarterly, to the Comptroller, in such form as he may prescribe, and that the books of accounts shall be subject to his examination.

The highest bidder will be required to pay the auctioneer's fee, and deposit with the Comptroller, at the time of sale, the sum of \$2,000, which sum shall apply to the rent first falling due, if the lease is executed, and shall be forfeited to the city if the purchaser shall fail or refuse to execute the lease when notified and required by the Comptroller; provided, also, that satisfactory security shall be furnished for the faithful performance of the covenants thereof.

The right to reject any bid is reserved if deemed for the interests of the city.

—and which is in direct conflict with the resolution of the Board of Aldermen of New York City, directing the Sinking Fund Commissioners to insert a clause, that there shall be no more than two cents charged for foot passengers.

This ordered sale of course is in conflict with law, and will deter bona fide capitalists bidding for it, to the injury of New York's treasury.

We would respectfully request that your Honorable Body instruct the Corporation Counsel to restrain the Comptroller from selling said franchise, that is to take place on the 13th day of February, 1883, at the Comptroller's office, at twelve o'clock, noon, and we will ever pray for your future success and prosperity.

FIRE DEPARTMENT.

NEW YORK, February 10, 1883.

A meeting of the officers designated in section 13, chapter 742, Laws of 1871, to purchase premises for the use of the Fire Department of the City of New York, was held at the Mayor's office February 10, 1883, at 2 o'clock P. M.

There were present Franklin Edson, Mayor; Allan Campbell, Comptroller; Hubert O. Thompson, Commissioner of Public Works, and John J. Gorman, President of the Fire Department.

His Honor the Mayor was called upon to preside, and John J. Gorman, President of the Fire Department, was chosen secretary.

On motion, the reading of minutes of last meeting was dispensed with.

The Comptroller moved that the resolution adopted October 6, 1882, be amended by substituting one hundred and sixty (160) for one hundred and forty (140), so that the resolution as amended read as follows :

Resolved, That the President of the Board of Fire Commissioners be and is hereby authorized to purchase the plot of ground, fifty (50) by one hundred and sixty (160) feet in size, situated on the east side of Riverdale avenue, four hundred and fifty (450) feet north of the line dividing the property of Lewis L. Delafield and Hiram Barney, at a cost not exceeding one thousand (\$1,000), to be paid by the Comptroller from the proceeds of bonds to be issued for the purpose, and upon the approval of the title by the Counsel to the Corporation.

Which was adopted by the following vote, viz. :

Affirmative—The Mayor, the Comptroller, the Commissioner of Public Works, the President of the Board of Fire Commissioners.

On motion, the Board then adjourned.

Whereas, It appears in one of the morning journals of this date that the Board of Police, acting as Trustees of the Police Pension Fund, are charged with illegally or improperly administering the same; and

Whereas, The Board of Trustees, in pursuance of section 1, chapter 330, Laws of 1882, on the 15th day of January, 1883, submitted to the Common Council of the City of New York their annual report, giving in detail the items of receipts and disbursements on account of the same for the year ending December 31, 1882 (which report was published in the CITY RECORD, January 24, 1883, No. 2933, page 141); therefore

Resolved, That his Honor the Mayor be and is hereby respectfully requested to direct the Commissioners of Accounts to examine into the affairs of the said Pension Fund, and to verify the said report by personal investigation, at their earliest convenience; and that the result of such investigation be given to the daily journals for publication as soon thereafter as practicable.

Whereas, Communication has been received from his Honor the Mayor stating information that Salmi Morse proposes to open his place of amusement, Nos. 139 to 143 West Twenty-third street, on this (Saturday) night, with the intention of producing what is called the "Passion Play;" and notice having been received that no license has been procured for such purpose; therefore,

Resolved, That the Superintendent be and is hereby directed to issue necessary orders to prevent the said theatre from being opened for public performances until license therefor has been granted, as provided by law.

LAWS OF NEW YORK, 1883.

CHAPTER 3.

AN ACT to provide for the payment of inspectors of election in the city of New York, for services rendered by them in the year eighteen hundred and eighty-two.

Passed January 31, 1883; three-fifths being present.

The People of the State of New York, represented in Senate and Assembly, do enact, as follows :

Section 1. Upon the certificate of the chief of the bureau of elections in the city of New York as to the period of service, compensation at the rate now fixed by law shall be paid to the inspectors of election in said city who were appointed in the year eighteen hundred and eighty-two for their services actually rendered, notwithstanding the failure by any inspector to comply with some requirements of law relating to his duties.

Sec. 2. This act shall take effect immediately.
